

ECOMEMBRANE S.P.A.: ADMISSION TO TRADING ON EURONEXT GROWTH MILAN

The Cremona-based Company, specialized in the design and construction of gasoholders for the production of green energy, will debut on the Stock Exchange on April 28^{th.}

Gadesco Pieve Delmona (CR), 26 April 2023 – Ecomembrane S.p.A., ("Ecomembrane") a leading company in the design and construction of gas storage and containment systems for the production of green energy, announces that today, Borsa Italiana S.p.A. has approved the admission of the company's shares to trading on Euronext Growth Milan (EGM), a multilateral trading facility organized and managed by Borsa Italiana S.p.A. for small and medium-sized businesses with high growth potential.

The start of trading is scheduled on Friday, April 28th, 2023, with ISIN code: IT0005543332.

The Placement consisted of a total of 1.758.800 ordinary shares, including 1.294.117 newly issued ordinary shares, 235.294 ordinary shares sold by Engineer Lorenzo Spedini, and 229.389 ordinary shares subject to the overallotment option, for a total value of approximately 15 million Euro. Subscription requests have been received from high-level Italian and international investors with a long-term time horizon.

The price of ordinary shares was set at 8.50 Euro per share, corresponding to a post-capitalization market value of 36.5 million Euro.

The listing is promoted and supported by Private Equity Partners, which will work alongside Ecomembrane in the role of Financial Advisor and with a direct presence on the Company's Board of Directors, even after the listing, in order to continue to contribute to the Company's growth and development, both domestically and internationally.

Ecomembrane specializes in the production of gasholders, gasholder domes, odor-control covers using PVC-coated polyester fiber fabric membranes, and every component of products needed for biogas combustion and power generation. Its target market is renewable energy and biogas, at the centre of the energy transition process involving the entire planet.

Founded in 2000 and led by Founder and CEO Lorenzo Spedini, Ecomembrane defines itself as one of the founding fathers of membrane gasholders in the modern era and is among the first to take gasholders worldwide in the name of sustainability, technology and reliability of its products. Today Ecomembrane is among the most internationalized companies in its sector, with a commercial presence on all continents and in 40 countries, with offices and production units in Italy and the USA. As of December 31, 2022, Ecomembrane's revenues were €14.2 million (compared to €11.7 million in FY 2021), with Ebitda of €3.3 million, compared to €2.4 million in FY 2021.
